Obsolete 213904-1.

Reason for Changes:

Discontinuance. 213904-3 is the replacement for 213904-1. Since Nov 2008, 213904-1 and 213904-3 have been identical parts. Prior to Nov 2008 the 213904-1 was not RoHS compliant due to chromate coating on the steel screws. After Nov 2008 RoHS compliant screws were used on both the 213904-1 and 213904-3. There is no reason now to maintain both part numbers.
