The following Phoenix Contact products have been modified. Existing specifications will be met or exceeded. Please review and acknowledge this document and inform your personnel as needed.

Description for Product Change Notification

The SPEEDCON thread on the shielded M12 connectors with QUICKON connection has been changed to a full-thread M12. As part of this change, the surface of the M12 thread has been tin-plated. In addition, the cable seal has been changed from NBR to FKM and the maximum external cable diameter has been extended to 10 mm. The sealing ring on the cable ring has also been changed from NBR to FKM. It is green for better visibility. The possible connection area of the IDC terminal blocks is indicated on the housings. This is being adapted, as the possible connection area could be extended for some items. The properties of SPEEDCON are no longer possible. All other properties remain unchanged or will be extended.



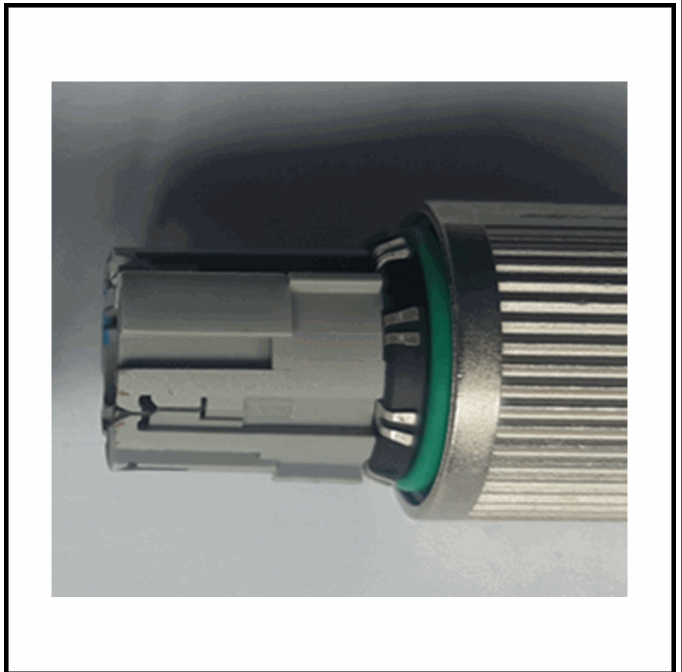
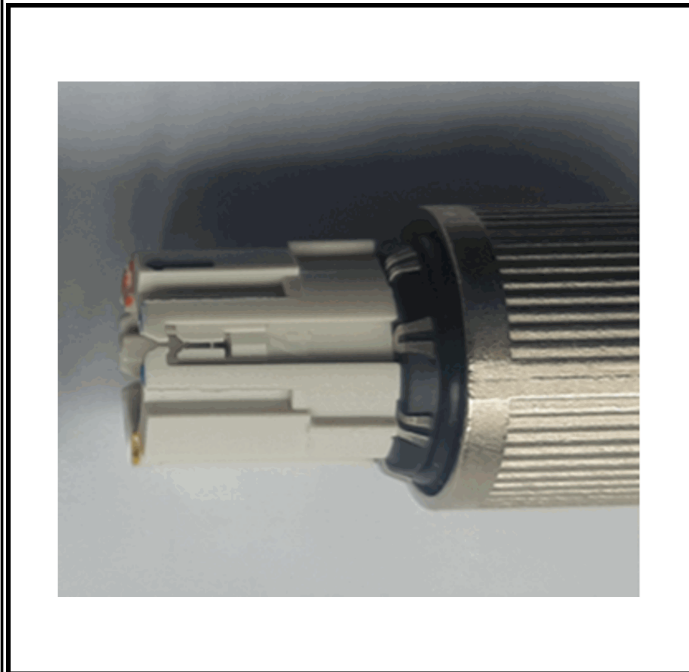
