General Product Description:

Terminal Junction Product

Description of Changes

TE Connectivity (TE) has changed preferred adhesive material used to bond plastic to plastic terminal junction components Ablestik adhesive EO 0202 (Manufacturer Henkel) to ECOBOND 104 adhesive (Manufacturer Henkel). Assembled parts were submitted to a full series of testing (Visual and Mechanical Examination, Contact Insertion/Removal forces, Contact Retention, Dielectric Withstanding Voltage (Sea Level), Thermal Shock & Fluid Immersion) prior the change approval. Adding to this, ECOBOND 104 adhesive has been used for other Terminal Junction products as splices and Series II assemblies, this change will allow to unify different adhesives for the same types products.

Reason for Changes:

Product improvement. Product improvement. TE's supplier/manufacturer Henkel notified that the adhesive that is used in the TJ assembly was going to be obsoleted from the market with short notice. Do to this notification TE had to find another adhesive alternative with the same performance. With these change we are unifying the usage of the ECOBOND 104 adhesive into the Hermosillo plant. According to the good results TE determined there is no, change to the form, fit or function of these products because of this alternative adhesive. The design of the components will remain the same and all part numbers remain unchanged.
