This notice serves as a formal communication from GE Critical Power regarding End of Life status of CLP0212 RevB power supply models effective as of the dates set below. The termination of CLP0212 RevB models has become necessary due to EOL of a component used in that power supply. However, GE has made available a replacement power supply for four out of the six models.

GE Critical Power is committed to providing the highest level of customer care during this time and will work with you to ensure a smooth transition. Key timelines listed below indicate milestones for end of life notice for the affected power supplies.

1. Customer to acknowledge receipt of this notification immediately.
2. Customer to place a “one time last time buy” of the impacted PSU by Sep 1<sup>st</sup> 2015.
3. Customer to place sample request for appropriate replacement PSU and transition to the replacement at the earliest.
