RE and REL relay - change of the material for cover production

Description of Changes

We are facing global shortages in resins. To avoid immediate line stops the current cover material of RE & REL relay Crastin needs to be changed to the already qualified alternative material Durethan. While both materials have the same characteristics, passed the same tests and are both UL and VDE certified, the new material colour appears slightly lighter. The Relay form (dimensions), features and ratings keep unchanged. Until the end of the material shortage mixed deliveries cannot be avoided.
