Description of Changes
1)Due to the global market shift from UL-V2 resins to UL-V0 resins, TE will be consolidating resins globally eliminating UL-V2 housings and offering UL-V0 alternatives in response to this shift. All new UL-V0 alternatives will meet or exceed the performance levels of the UL-V2 housings being replaced. The following part numbers 1-480435-0 and 1-480435-5 are being superseded. A last time buy opportunity is provided as per the dates stated thereafter. Please note that new conditions may apply, please contact your local customer sales representative for a quotation. 2)This is a courtesy notification to let customers know that due to market conditions, effective immediately, we will be adding an alternate resin to produce existing housing 2-480435-2 that meets or exceeds specified performance requirements in effort to meet requested customer delivery dates. There is no form, fit or function change.

Reason for Cancellation:
In order to allow customers more time to approve and transition to newly proposed V0 alternatives, we are pulling back our plan to supersede the impacted V2 housings until later this year. We will continue to support both V2 and V0 alternatives at this time. Our new plan is to target Oct 1, 2019 for this transition giving customers enough time to make needed changes. We will send new notifications prior to the new implementation date.
