## Typical Temperature Rise vs. Current Characteristics:



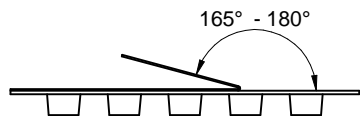



#### Packaging:


