

# Honeywell Announces Obsolescence and Last-Time Buy Opportunity for Certain Sealed Switches, Toggles & Rockers and Precision Thermostat Part Numbers

Honeywell is announcing an opportunity to place a last-time buy order in relation to certain Sealed Switches, Toggle & Rocker and Precision Thermostat part numbers. This announcement relates only to the part numbers specified below; it does not represent a full discontinuation of the product lines into which such part numbers are grouped.

We apologize for any delays in shipments and have been analyzing ways to improve productivity. This analysis has uncovered a large number of rarely, infrequently used parts that complicate our supply chain. Our plan is to simplify our offering and improve our cycle time through reducing those infrequent SKUs. This notification will allow you to purchase such SKUs one last time.
