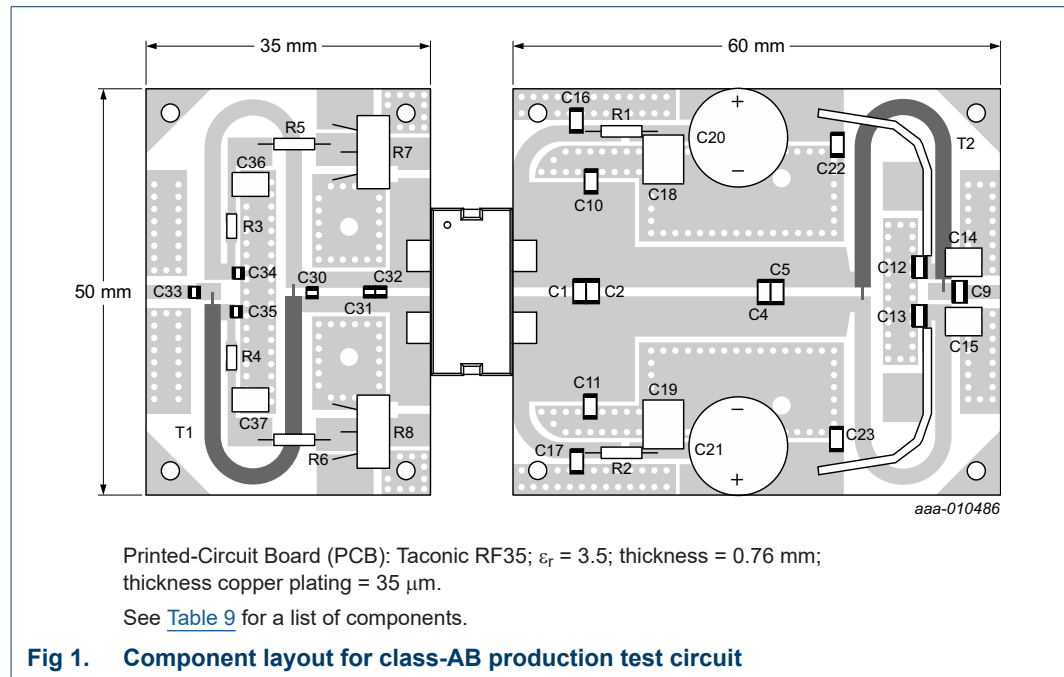

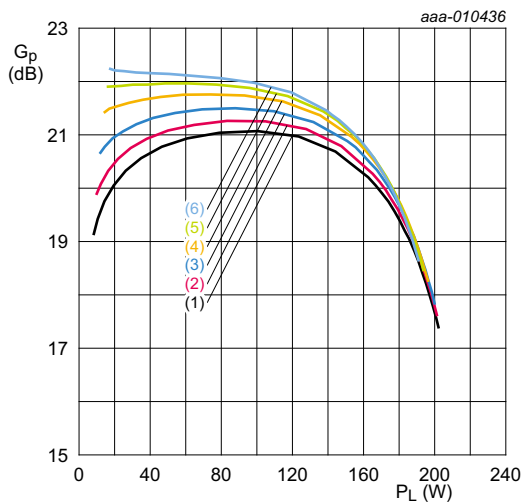

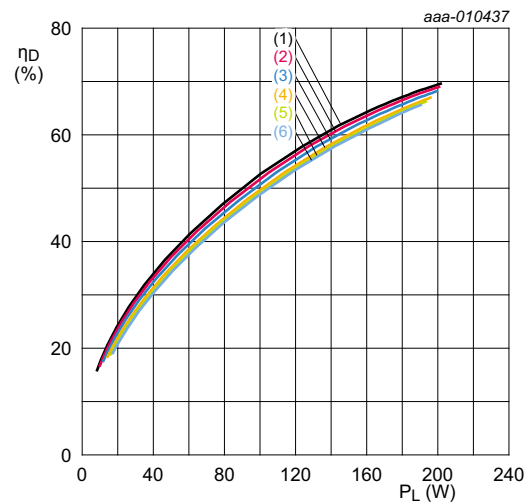
Fig 2. Power gain and drain efficiency as function of output power; typical values

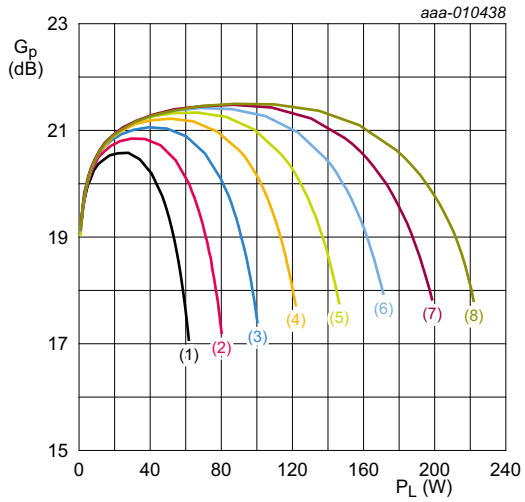
Fig 3. Power gain as a function of output power; typical values

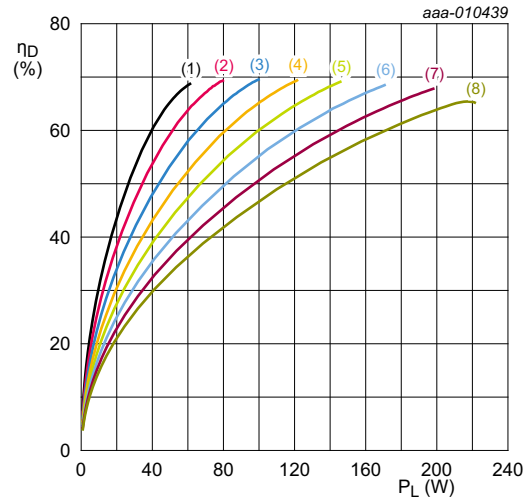

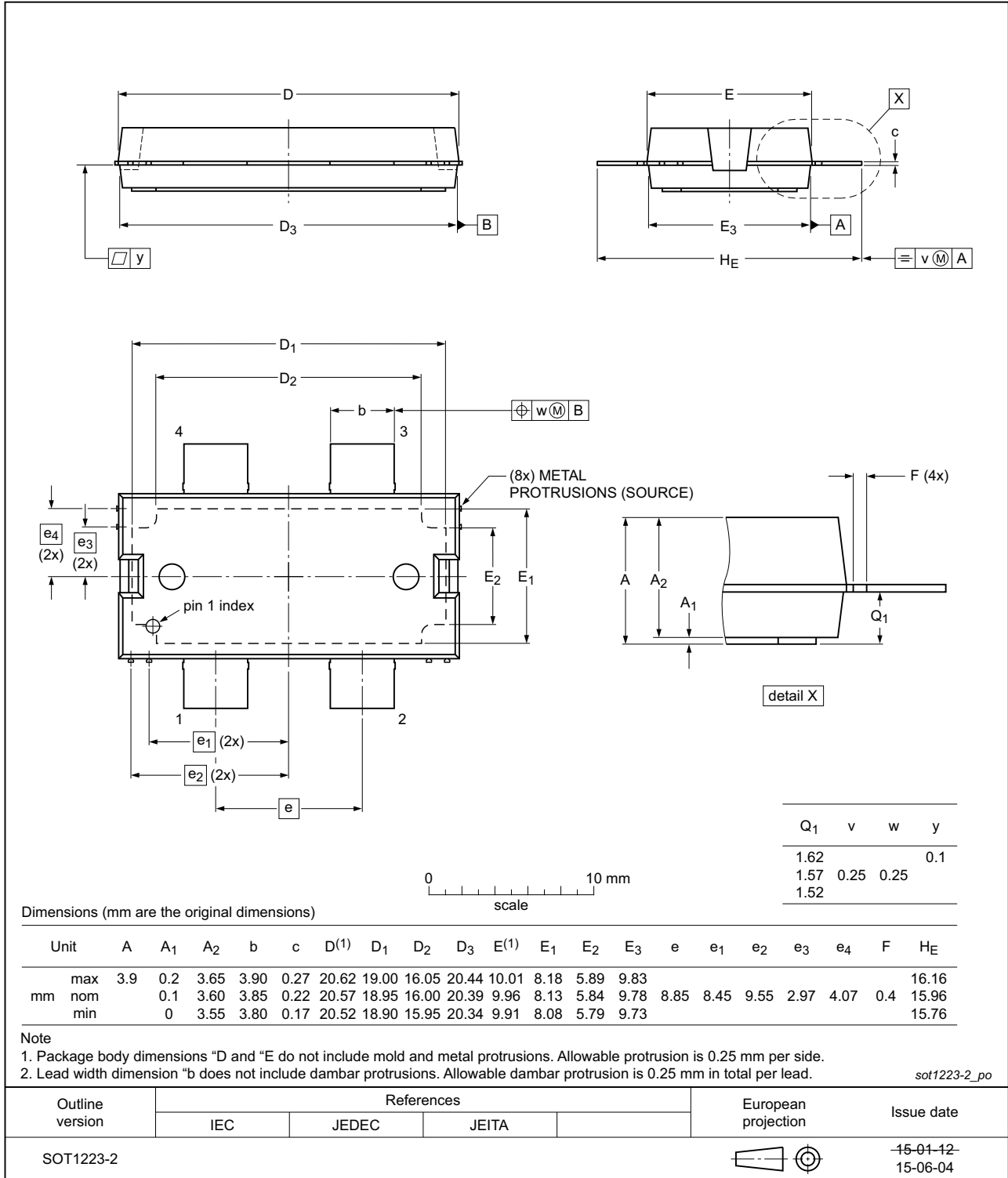


Fig 7. Package outline SOT1223-2 (HSOP4F)
