<b>Description of change</b>	Created new article number for <b>preassembled</b> Power Supply and USB-Cable Set.
<b>Reason for change</b>	The article [EN101988] ACC-BASE-USB2.0-R1 is not a stock keeping unit but rather is a set composed of articles that are picked from Enclustra's inventory when shipping to the customer. In the past, this had caused a lot of confusion with incoming logistics at customers and customs, because the customer's order and the invoice stated the article number of the set, but the shipments contained the components of the set and were labeled with the corresponding article numbers of the components (which evidently are different from the set numbers).
<b>Expected impact on customer</b>	None: this is an administrative change only.
<b>Forecasted key milestones</b>	Transition to new articles will be started immediately. Enclustra Sales will convert existing orders to new replacement articles (and will inform customers). Enclustra Sales will automatically substitute new orders for old articles with the new replacement articles (and will notify customers using this PCN).
