During the transition period, FCI will continue supporting existing partnumbers through modification of the bill-of-material. To ensure 100% traceability, the rule will apply that no mix of plating is allowed within a batch. It is anticipated that Gold plated pin inventories will be depleted within short period. Upon request, manufacturing unit will provide details on first batch using GXT™ per finished product partnumber.</p> <p>After completion of conversion of xxxxx-3xx and xxxxx-7xx to xxxxx-1xx, the -3xx and -7xx partnumbers will be withdrawn from the market. This expected to become effective latest end 2009.</p>
